ITEM 2 - CORRESPONDENCE

- 2. <u>Chairman</u>. The Chairman had received correspondence regarding mooring fee increase for Battle-Bridge Basin residents. While RBOA have a primary interest in this subject, some of the affected boaters are NABO members and therefore deserve our involvement in the debate. The (ongoing) mooring fees issue is to be the subject of urgent attention by the **new Council**.
- 3. **General Secretary**: The General Secretary had received advance notification of the 2002 IWA Festival. Participation in this show is to be addressed by the **new Council**.

ITEM 3 - PRE-AGM ISSUES

- 4. **Constitutional Requirements.** Council discussed at length the Constitutional requirements regarding the process that governs the nomination and election of Council Members. While there was confidence that that the likelihood of an election was low (due to the standing down of Roger and Andrew), the meeting fully explored the surrounding issues and concluded that the possibility of a postal vote was also equally unlikely.
- 5. <u>Statutory Timescales</u>. As the August issue of NN did not contain a copy of the Council proposal form, Council agreed to extend the nomination deadline to 31 Oct. To notify the membership of this extension, it was decided that an addendum would be included in the (about to be issued) copy of NABO news the agreed words were:
