3 MOORINGS AND LICENCE ISSUES (default)

John reported on the Moorings Consultation meeting on 28th May, which was chaired by Sally Ash who failed to meet promises on deadlines. The lengthy report was produced but not gone through. User group responses were the opposite of individuals.

The main conclusions were to scrap the idea of an individual to chair the mooring groups and BW should chair. So much time was spent on the discussions at the start of the meeting that the conclusions were rushed through at the end of the meeting.

Zoning idea was approved with boaters paying for a roving mooring permit. This presents another enforcement problem

BW is to look at charging Pubs for moorings.

Short term mooring overstaying charges were discarded as the meeting ran out of time.

John showed a document from 2009, that EA had produced, on the same subject that ran to 4 pages and was clear and concise.

We agreed the policy for residential moorings as per RBOA.

BW suggested a salvage bond as boats sinking on moorings were causing a problem – discussion took place on how this would work. David commented that every boat that sinks is a problem solved in terms of mooring/licensing issues. We need to wait for 'notes' of the meeting then do our response with a need to be constructive.

The papers are now on the BW website under consultations.

David reported on the Wilts Council meeting attended by Geoff and Andy. BW's only representative was Damien Kemp who is on a short term contract and therefore couldn't answer any policy questions. BW is wanted to enforce 14day and 48hr moorings.

BW's excuse for everything now is that they can't afford it.

Licence issues.

BW have decided not to stop the prompt payment and licences will be increased by 1% in August. BW thinks the Third Sector will be able to forecast better for future increases. Nabo believes it was a good response.

4 LEGAL UPDATE

Nabo wrote to BW in response and has received a letter from Sally dismissing our claims. A letter has been sent on advice from Mark Beasley and we are again awaiting a response.

There has been no response to Geoff's letter or to letter requesting a meeting. Nabo is unable to take our legal challenge to the Ombudsman as it is a legal matter and is also unable to take it to Judicial Review.

A solicitor in Northwich involved in a section 8 case has remarked that the Acts are so vague as to be useless. He has been put in touch with Mark Beasley. The BW Bye Laws are to be reviewed.

Bone-fide cruising raised its head again. There are issues with enforcement as BW is in limbo recruiting new staff and then training them.

A case is coming up in August on the K & A and BW is hoping to set up a precedent. Geoff and Andy are keeping an eye on this.

CC guidelines need discussion with ideas needed. If BW don't enforce any system will fail. David is to contact Paul Griffiths

The BW's report on the 2009 NABO waterways condition survey stats:191 responses listed places needing urgent attention, of which 32 were rated "completed", 75 "in hand 2010" and 7 "In hand 2011/later": a total of 60%. 56 remained "to be investigated" while 21 BW classed as "disagree/no plans for action". 6 FINANCE

Stephen reported that the bank balances to date are Alliance and Leicester £2033 Barclays' current a/c £6318 and deposit a/c £23,717 giving a total of £32,068 Stephen has received a corporate reference number from HMRC

7 MARKETING AND MEMBERSHIP

a) Crick. This was fine and David, Richard and John enjoyed themselves. The corporate image was good, as was the visibility. The event cost £650 ish less the sale of windlasses. (four boxes were found at the Darlington's) 7 members joined plus 3 online to date. Over 1000 leaflets and flyers were given out. Richard talked to stall holders about them submitting articles for Nabo News advertising their products.

There seemed to be a large proportion of visitors wanting to buy a boat to live on – and with very limited understanding of the ramifications – we handed out more than 100 of our publications "So you want to buy a boat?".

Richard is planning a road show for marinas in the winter.

Richard explained the costing and ordering of the merchandise and has sent John details for the website.
