- 2) Minutes of last meeting
 - i) Minutes **13**th **June** April approved unanimously. Actions are complete unless recorded below or updated in agenda.
 - ii) Matters Arising and actions:

RCR no action expected now. There is no better deal available. Therefore we will try and sell the space in NN and drop RCR when it suits us.

We have no candidate for London rep. David will look at recent recruit names and circulate.

3. (vi) Bridge automation. Phil reported that things were going slowly. There are reportedly safety concerns. David will ask at NAG.

4. (iii) Boater representative elections. Stella raised the issue that boaters without access to mail and internet were not able to receive the information for this. Mike will raise with CRT.

Policy Discussions: Matters requiring agreement and action from this meeting

i). Report and discussion on meeting with Mike Grimes of CRT Mark and Mike had met with Mike Grimes, newly appointed Head of Boating, responsible for private and commercial boating, licencing and evasion. It was a déjà vu moment, similar to several others in this post and more senior. He said that he understands that they have ignored customers. Example given of announcement that meetings with National Boating Organisations were going to stop, with no discussion etc. Mike also presented an example of a badly worded enforcement letter (later Mark was asked to rewrite it for them!), and the case of a boat stuck behind the Rufford breach without help was raised. There is some evidence of new thinking, and we have cautious optimism. As there will be no further meetings between CRT and the National Boating Associations, we have to ensure that we drive the individual meetings between CRT staff and NABO.

ii). Winter moorings. CRT plans for WM have been announced and they are to drop the roving mooring option as used last year. Council reiterated support for VMs in the old style of fixed location, and tolerance of residential status. Steve Haywood in Canal Boat has written that he is convinced that 'changes in the winter mooring' are due to NABO's objections and that this will not help recruiting from CC boaters. ACC

iii). CRT Terms and Conditions.

CRT have not replied to our submission and will not do so. We have the latest comments from Shakespeare to hand. Council concluded that we should not let this rest and write to CRT to put them on formal notice of our objections. Council discussed the suggestion from Shakespeare that we advise members to qualify their renewals with a prepared suggested legal statement. It was agreed that this should be subject to further discussion and decision. We should at least advice CRT of this beforehand so that members were not inconvenience by CRT refusing a licence as a consequence.

iv). CRT enforcement

Stella raised over evidence that that CRT are acting numerically disproportionately against those least able to defend themselves, through age, medial issues, and lack of IT support.

4) CRT Matters

i) Meeting with CRT and National Boating Associations

This took place on 6 July with the main items being winter moorings, enforcement work flow, and licencing. These items covered in MT's report circulated previously.

ii) Report on London situation.

CRT announced that VM's would be £25 per day. BRG rejected this as there was no prior notice or consultation. It is now being consulted on.

iii) New CC requirements

CRT have some published data covering number of part period licences issued for not moving enough. The most obvious fact is that the numbers are not very large.

5) Membership, promotion and marketing

i) Update of attracting new members.

The rate of new members has dropped to a steady drip, rather than flow. A reprint of pamphlets has been made.

ii) Report following meeting with RCR.

As noted above under notes of last meeting.

iii) Planning for AGM.

Council nominations are now due, and must be finished by 2nd October. There was discussion on the merits of a speaker, and we were reminder that last year we concluded not to have one, and have a first Council in the afternoon, being more time efficient. The matter of electronic membership was briefly discussed. There were recognised to be benefits but also some disadvantages. It was concluded not to generate a resolution for the AGM in haste, but further consider the issue.

iv) Regional representatives.

Chairman asked what they were doing and how we could encourage them to be proactive in reporting on local issues. Could we think of a simple was of reporting so that there was a steady flow of information? Mike will contact all and see what is to be done.

The BSS office and a subcommittee are looking at improvements to the risk assessment methodology as good industry practice. Trevor raised concerns about how long this will take.
