

Refreshing signage and rules for South East visitor moorings sites: boater consultation Jan-Feb 2013

Introduction

Over the past two years the South East (SE) waterway team has been consulting via its local user group meetings on proposals for refining time limits and improving facilities at its most popular visitor mooring sites. A priority list of 22 locations was developed and widely circulated. More recently, we have a new policy commitment from the Trust's new governance bodies on reducing overstaying on visitor moorings and improving compliance with rules for boats without a home mooring.

It is a priority for us to improve the chances of boaters finding space to tie up when they arrive at designated visitor moorings.

This paper takes as a starting point the proposals on which the SE team has already consulted with those represented at user group meetings. To these, it adds the new dimensions introduced in the policy briefing endorsed by Council and Trustees in September 2012 (this is downloadable from http://canalrivertrust.org.uk/publication-scheme/legal-and-governance/council-papers). The scope of the consultation is also extended to reach directly as many boaters as possible who are likely to be affected.

We are aware there are more locations in SE where either existing visitor moorings need reviewing or new visitor moorings created. This is beyond the scope of this current consultation which needs to focus on testing the new time limits and processes at the sites already highlighted before extending the approach to other places. When the time comes to make changes at other SE sites, we will apply the principles and lessons learned from this consultation and subsequent implementation.

Increasingly, we are looking to the boating community to work with us to plan improvements to visitor mooring arrangements throughout the country, but ask for understanding that achieving agreement and implementing changes takes time and money and we have to prioritise.

We want to ensure that all boaters, and particularly those making regular use of visitor moorings in the area in question, have the opportunity of considering the proposals for the 22 sites (see below) and registering their comments. We are prepared to modify local proposals where a good case is made for change which is consistent with national policy. Where arguments are put forward that we cannot agree with, we will explain our reasoning.

Because of the already extended period of consultation with organised stakeholders, we are asking for feedback on the proposals before 1st March 2013. A pro forma is appended for written feedback - using it will reduce the amount of manpower needed to collate and digest responses.

We would like to start implementing the new arrangements in time for at least some of the sites to 'go live' soon after Easter 2013. We are planning for a phased approach, starting with Thrupp, Stoke Bruerne and Foxton, where detailed planning for the changes is underway. We will review the success of these within 6 months of implementation, and modify detail as needed in the light of lessons learned. We aim to establish a small working group of boaters to help us with this.

This consultation for the South East is the first in what we intend will be a series of local reviews eventually covering the whole of the network. We will learn from the feedback from this consultation, and hope that our new waterway partnerships will take an increasing role in further local reviews. We

welcome other suggestions for stimulating greater compliance with maximum stay times at visitor moorings and will consider testing these in other areas.

How we are advertising this consultation

It is published on the 'current consultations' page of our website and linked from the January issue of Boaters Updates which also reaches the waterways press. We hope news of it will spread by word of mouth on the towpath telegraph and virally via newsgroups.

We are sending the consultation direct to all licence holders who have registered an email address with us and whom we have either sighted moored along the SE towpath on multiple occasions during the past year, or who have home moorings in the SE.

How to respond

The job of digesting comments is made much easier if you use the feedback form, downloadable as a word document from www.canalrivertrust.org.uk/consultations. Please complete and email this to consultation@canalrivertrust.org.uk before 1st March 2013. We hope that feedback forms will be reviewed by volunteers (see below). If you wish to remain anonymous, then leave your name off the feedback form, but do include it if you are happy for a response reviewer to contact you if they need clarification of any of your points.

If you are discussing the consultation with friends within the boating community and you all reach the same conclusions, it would help us if you'd together submit a single response, mentioning if you wish that it represents the views of X boaters. This isn't really a numbers game - it's persuasive reasons for particular amendments to the proposals that we need, rather than the number of people suggesting a particular approach.

Considering the feedback

There are two volunteer opportunities:

- 1. We need a few people with Excel & Word skills willing to give up a bit of time to help collate the feedback. The job would need to be finished by mid-March. We can't say how much time will be involved because we don't know how many responses we will receive or when they will arrive. Hopefully there will be enough volunteers to share it around and make it just a small number of hours each.
- 2. If you are in the Milton Keynes area on 19th March and would like to volunteer to join a small workshop to review and discuss the feedback (once it has been collated), we would like to hear from you.

We will publish a short report summarising the changes we have made to the proposals in the light of the consultation.

Overview of the new approach to management of overstaying at visitor moorings

The term "visitor mooring" is generally understood to be a site with some form of facilities – whether just a firmer edge with mooring rings or a more comprehensive range of services. Investment will have been made because of the specific location at a popular destination or access point. Passing boaters therefore need to be reasonably confident that space will be available when they arrive, as close as possible to the heart of the destination.

Where there is no sign, the default maximum stay is 14 days for any boat. It is some years since existing time limits at visitor moorings have been reviewed. As boat numbers have increased, so has the incidence of visitor moorings becoming full in some areas. Proposals are therefore designed to reduce average stay lengths at popular locations and to enable maximum possible turnover of visitors along lengths closest to the heart of the destination – e.g. close to the pub. For time limits to be effective, rules about frequency of return to the site are to be applied. For practical monitoring purposes, we are adopting the concept of a calendar-monthly 'allowance' for the total number of days that a boater may spend at a particular site.

Mooring Rangers will be engaged who, using electronic monitoring equipment linked to our licence database, will record daily sightings of all boats moored on the visitor moorings within the area. Information gathered will enable tailored communication with individual boaters to help them adhere to designated stay times. Extended stay charges of £25 will be invoiced to boaters mooring in a zone (see map) or area for longer than the time specified. In exceptional circumstances (and in accordance with our Schedule 2 of the licence conditions), we may give permission to a boater to stay longer and will give directions as to where in the area they should moor so that other boaters are not disadvantaged.

We will publish clear information for boaters on an area by area basis to make it as easy as possible to understand and comply with new rules. Mooring rangers will distribute leaflets, and signs at the relevant sites will be refreshed to reflect the new arrangements, including new totem tiles indicating the charges for extended stays. At some sites, new "Welcome Signs" will be provided to help visitors locate the different mooring zones.

Proposals

These are appended as follows:

- A schedule of visitor mooring sites detailing the proposed changes to stay times for each location
- Draft text for the Thrupp information leaflet, map and letters that would be used to implement the new arrangements. We have worked up this example for Thrupp covering a length of some 1.75kms from Br. 220 – 224 on the Oxford Canal. This will probably be the most complex scheme, with others covering similar or shorter distances but containing fewer time limit zones. We have started with this site because Thrupp Canal Cruising Club has kindly offered to trial our new electronic monitoring equipment and process.





Welcome to Thrupp. We hope you enjoy your stay.

The map in this leaflet shows the various mooring zones in Thrupp between Bridge 220 and Bridge 224. 2 days, 7 day or 14 day moorings are available – look for the signs on the towpath posts.

An extended stay charge of £25 per day applies if ...

- you do not move on after the maximum stay time within any one of the zones between bridges 220 and 224
- you stay longer than 14 consecutive days between bridges 220 and 224, or
- you spend more than 14 days between bridges 220 and 224 during any calendar month

The area is visited daily by a mooring ranger, working on behalf of the Canal & River Trust, who records your boat number. Extended stay charges will be invoiced monthly and recorded on your boat licence account.

The lengths marked as 'private moorings' are managed by Canal & River Trust, Thrupp Canal Cruising Club and Oxfordshire Narrowboats for boaters with long term permits.

Please respect the mooring zones; they are designed to ensure mooring space is shared fairly between all.

Casual and Visitor Towpath Moorings in Thrupp – Summary Terms and Conditions:

The towpath between bridges 220 and 224 is divided into zones reflecting their relative popularity and proximity to local pubs and other services. Time limits are signed on totem posts along the towpath verge and explanatory signs including a map are located at either end of the length.

The signed time limits indicate the maximum length of stay within a zone during any one visit. Additionally, there is a limit to the total number of days your boat may spend within the area in any one visit and also in any one calendar month, without payment.

An extended stay charge of £25 per day applies if:

- your boat does not move on after the maximum stay time in a zone for a single visit, or
- your boat does not move on after 14 consecutive days in the mooring area, or
- it spends more than 14 days in total in the mooring area in any one calendar month.

This charge reflects our costs of keeping the visitor moorings available.

A Mooring Ranger records the index number, date, time and location of each moored boat on a daily basis. This information is the basis for the calculation of extended stay charges.

We will make reasonable efforts to contact the boat's licence holder to give warning and notification of extended stay charges. This may be by phone or text or a letter delivered to the boat. It is however your responsibility to keep track of the time limit and move on without waiting for a notification.

Extended stay charges will be invoiced monthly and recorded on your boat licence account. Your account must be paid in full within 28 days. Debts will be recovered through our normal processes which may include obtaining a County Court judgement.

DRAFT FULL TERMS AND CONDITIONS for use of casual and visitor towpath moorings in Thrupp, Oxford Canal

Purpose of the terms and conditions

To achieve fair sharing of limited mooring space and maximum benefit to the local community in this popular Oxfordshire village.

Overview of mooring arrangements

The towpath between bridges 220 and 224 is divided into zones reflecting their relative popularity and proximity to local pubs and other services. Following general principles, longer time limits have been allocated to zones on the outer edge of the area, whilst shorter time limits apply to zones where a greater turnaround of boats will deliver the most benefit. Time limits are signed on totem posts along the towpath verge and explanatory signs including a map are located at either end of the length.

The signed time limits indicate the maximum length of stay within a zone during any one visit. In extended stay charge of £25 per day applies if your boat does not move on after the maximum stay time in a zone for a single visit, or if your boat does not move on after 14 consecutive days in the mooring area, or if it spends more than 14 days in total in the mooring area in any one calendar month. This charge reflects our costs of keeping the visitor moorings available.

A mooring ranger records the index number, date, time and location of each moored boat on a daily basis. This information is the basis for the calculation of extended stay charges as detailed below. Information detailing the zones and time limits within the area is published in leaflet form, on local signs and on our website. We make reasonable efforts to contact the boat's licence holder to give warning and notification of extended stay charges. This may be by phone or text or a written communication delivered to the boat. It is however your responsibility to keep track of the time limit and move on without waiting for a notification.

In exceptional circumstances (and in accordance with Schedule 2 of the licence terms and conditions), we may give permission for a boat to stay in the visitor moorings area longer than the time allowed. You must contact either the ranger or the local Boating Co-Ordinator to apply for authorisation from the local Enforcement Officer. Extended stay charges may still apply.

Please note, these Terms and Conditions may be suspended during special events, but only by our express permission. In these cases, notices will be posted locally and on the Stoppages/Restrictions pages of our website.

Extended stay charges will be invoiced monthly and recorded on your boat licence account. Your account must be paid in full within 28 days. Debts will be recovered through our normal processes which may include obtaining a County Court judgement.

Definitions and clarifications

Area time limit: the maximum total number of days that a boat may spend anywhere in the visitor moorings area in any one visit

Arrival time: the arrival time is recorded as the time at which the ranger first records the boat within a zone.

Monthly time limit: the maximum total number of days that a boat may spend anywhere in the visitor moorings area in any one calendar month

Mooring ranger: the person whom we have trained and authorised to record boats moored along the length on a daily basis and to communicate reminders at our request. Ranger visits may take place at any time of the day.

Recorded stay time: is measured by the number of nights between the first and latest sighting. A boat recorded at any time on two consecutive days will be treated as having stayed for one whole day and a single sighting of a boat on one day only will also be recorded as a one day visit.

Summer - 1st April - 31st October

Thrupp area: Visitor moorings between Bridge 224 and Bridge 220 on the Oxford Canal

Visit. any period when the boat is tied up and not navigating.

You/yours: the boat's licence holder, or person in charge of the boat with the licence holder's consent.

Zone time limit: the maximum number of days that a boat may spend within the zone on any one visit.

Zone: a length within the visitor mooring area with a specified time limit
